## **PHOSPHORUS! PHOSPHORUS! PHOSPHORUS! PHOSPHORUS!**

- Phosphorus is one of the leading causes of lakes and rivers turning green. Under summer weather conditions, one pound of phosphorus can create 300-700 pounds of algae.
- Fertilizers, leaves, grass clippings, eroded soil, animal waste, and ashes from burning all contribute to the build up of phosphorus in our lake.
- Use **ONLY phosphorus free fertilizer, the middle number should be ZERO, must be used. It is a new Minnesota law so please abide.**
- If necessary to kill weeds, particularly near the lake, use products such as Rodeo that is lake friendly and non-toxic to fish. It is available from stores such as Ag Service Country Store. Also, works well in flowerbeds.

## **MORE ABOUT PHOSPHORUS !!!!**

Believe it not a recent study has shown that automatic dishwasher detergents contribute 3% of the phosphorus load into state lakes. Local grocery stores carry one brand, Seventh Generation, while other brands are available from private vendors.

## **NOTES FROM NON-PROFIT EDUCATION FOR MUNICIPAL OFFICIALS (NEMO) PRESENTATION:**

As we reach maximum development around the perimeter of our lakes and as the 2<sup>nd</sup> and 3<sup>rd</sup> tier of developments continue to expand, the ability to **LOVE OUR LAKES TO DEATH** becomes very real. No one individual will ever be singled out as the cause of the eventual deterioration of a lake. All property owners within a watershed will ultimately be accountable for the final outcome. What this means is that all of us collectively, lakeshore owner and non-lake shore owner alike, have an impact on the health of our lakes. A sobering point is that once a lake degrades beyond a certain point, it is nearly impossible to bring it back to health. As reported in the Echo Press December 17, 2003, Bruce Campbell, Ida Lake Association president, received some notoriety as a result of being a spokes person in favor of the Douglas County Board taking action in approving a no-wake ordinance for Pristine Bay on Lake Darling and a no-motor ordinance in Lake Ida's Johnson Bay. The Department of Natural Resources (DNR) will make the final decision about the ordinances.
